1. RATIONALE

1.1	The Pupil Premium Grant is designed to tackle the achievement gap between students from low-income families and their peers. After prior attainment, poverty is the single most important factor in predicting a child's future life chances. The chances of a student eligible for the Pupil Premium achieving five or more strong passes (grades 9-5) at GCSE including English and Mathematics across the country are less than one-third of those not eligible for this funding.		
1.2	The Pupil Premium Grant is additional to main school funding and is designed to address the underlying attainment inequalities between children who have been eligible for free school meals at any time in the previous six years and those from more affluent backgrounds.		
1.3	The Government allocates money to schools based on the number of students receiving free school meals within a six year date range. The money is not ring-fenced but should be used to improve outcomes for those children. There are also allocations for Children Looked After (CLA) and Previously Looked After (PLA) and Service Personnel Children.

1.4	All schools are free to spend the Pupil Premium Grant as they see fit, but will be held accountable for how they have used the additional funding by measures in the performance tables.			
1.5	The decisions we make on how to use the funding to improve the progress and attainment of the eligible students will be based on guidance provided by educational research as well as our analysis of the specific needs of our school and wider community.			
1.6	Evidence shows that the most effective schools narrow the achievement gap through a combination of high quality teaching, strong leadership, a relevant and coherent curriculum, a culture of high expectations and targeted intervention and enrichment activities.			
1.7	To use the Pupil Premium Grant to identify and support those students who have struggled with learning and their attainment has dropped as a result of Coronavirus closing schools and remote learning.
